SPRINGER Maschinenfabrik GmbH is based in Friesach and produces machines and haulage installations for the timber industry, such as log yard and planing and shaping facilities, machines for grading sawn timber as well as manufacturing equipment for the subsequent treatment of wood.

Within this field the corporation has, as a result of steady advancement and technological creativity, succeeded in establishing a generally respected and leading position in Austria and has risen to the rank of a market and technology leader Europe-wide.

A fundamental component of the success is the strategic orientation of the company to international markets and - connected to this - the continuous increase of their export ratio which is now around 90%. In the course of the successful development of new markets, subsidiaries were acquired in Italy, Sweden and Canada. On the part of the SPRINGER company, large-scale projects are being carried out in all continents, such as for example in the USA and Canada as well as in several South American countries.

One of Timo Springer's great concerns for many years now has been the training of apprentices, where happily more and more young women are also starting their apprenticeship in the company .Many apprentices have continued their career with SPRINGER on completion of the job training and are now long-standing valued colleagues of the firm.
